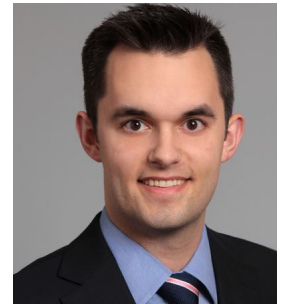


**Paige Malott, International District**
